I-25 to Hwy 7, go east for 0.3 miles to CR-2. Take a left on CR-2. Follow that for 3.8 miles to CR-17. Take a left on CR-17. Grounds will be on the right hand side 0.2 miles down CR-17. (signs will be available) Additional directions will be available from Ft. Lupton.
